6: Workshop: Debra Drescher, Texas Main Street State Coordinator

Debra shared that the State office has been holding calls with Main Street managers to share ideas, challenges, actions and solutions with one another. They are still having these calls 1x/month. She shared ideas from other programs-Webinars on transitioning to ecommerce, virtual tours of downtown buildings available, love notes to businesses and checkin calls from board members. Debra also shared the State program has a resource library that we have access to for updates, ideas, etc...

The board had discussions on ideas to implement. It was decided we would conduct a survey with the businesses in the program area to do an inventory of tools they have (websites, social media pages, ecommerce) in order to focus on how best to help through any promotions, trainings and webinars. We will also divide the businesses up amongst the board to make personal contact with the owners/managers, look into hosting some virtual happy hour shopping and maybe sidewalk sales to make use of the new improvements.
