#### **BACKGROUND/HISTORY:**

During the October 26<sup>th</sup> Council meeting, Rhian Nicholson requested the city to consider providing a Graffiti Wall in Fisherman's Park.

Graffiti was started in the late 1960's in Philadelphia by two artist named Cornbread and Cool Earl.

Graffiti has a lot of cons but it also has its pros. Graffiti is seen as a type of art to some people and as vandalism to others.

#### Cons:

- Can be viewed as vandalism
- It is illegal unless they receive permission
- Vapors from the spray paint are released into the atmosphere
- The cost to remove
- Graffiti can be used by gangs to mark their territory
- Curse words & inappropriate images
- It is technically destroying someone property

#### Pros:

- It's a type of art
- It's a way for artists to express themselves
- It gives life to a blank wall
