RESOLUTION NO. R-2020-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, APPROVING TASK ORDER NO. 4 WITH SEVENARROWS LAND STAFF, LLC, FOR LAND ACQUISITION SERVICES IN THE AMOUNT OF TWO HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED FIFTY AND 00/100 DOLLARS (\$266,250.00), AS PRESENTED IN THE ATTACHED EXHIBIT A; PROVIDING FOR A REPEALING CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the projected growth of the City of Bastrop (the "City") will soon result in wastewater flow rates that will exceed the capacity of the City's current wastewater collection system and treatment facilities: and

WHEREAS, the City Council has the vision to improve Bastrop's community safety by building Wastewater Treatment Plant No. 3; and

WHEREAS, engaging SevenArrows Land Staff, LLC, to provide land acquisition services for Wastewater Treatment Plant No. 3 meets the intent and is Item CS#15 in the City's Workplan; and

WHEREAS, Resolution No. 2019-117 authorized a contract with SevenArrows Land Staff, LLC, for land acquisition services and approved Task Order No. 1 in the amount of forty-six thousand and 00/100 dollars (\$46,000.00); and

WHEREAS, the City Council of the City of Bastrop desires to approve Task Order No. 4 with SevenArrows Land Staff, LLC, in the amount of two hundred sixty-six thousand two hundred fifty and 00/100 dollars (\$266,250.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, THAT:

- <u>Section 1</u>. The City Council of the City of Bastrop hereby approves Task Order No. 4 with SevenArrows Land Staff, LLC, in the amount of two hundred sixty-six thousand two hundred fifty and 00/100 dollars (\$266,250.00), as presented in the attached Exhibit "A".
- **Section 2.** The City Council of the City of Bastrop has found SevenArrows Land Staff, LLC, to be a subject matter expert in the area of land, right-of-way, and easement acquisitions.
- <u>Section 3.</u> All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

Section 4. This Resolution shall take effect immediately upon its passage.


