

In compliance with the Open Meetings Act, Chapter 551 Government Code, Vernon's Texas Code, Annotated, the items below may be discussed in closed session, pursuant to the Act, Section 551.071 – Consultations with Attorney: matters upon which the attorney has a duty and/or responsibility to report to the governmental body(s).
