# **USDA Emergency Food Boxes**

The Bastrop County Emergency Food Pantry, in collaboration with the Bastrop County Long Term Recovery Team and Ascension Catholic Church, is planning a food distribution next Tuesday afternoon, March 2nd, to distribute 375 USDA emergency food boxes to county residents. The pantry is planning to have about twenty-six volunteers to help with traffic flow, intake registration, and loading vehicles with the food boxes. A map is attached.

### February 26 B.E.S.T. Monthly Breakfast Meeting

This month's meeting was hosted by Bastrop County and held at Southside Barbeque. County Judge Pape had asked each community to be prepared to provide a summary of their response to the ice storm. Mayor Schroeder did a terrific job of describing Bastrop's response and communication efforts. It was good to listen to stories from the other communities, school, and Bastrop County. Their reports served as confirmation of the good work that takes place in all cities during emergencies, and the importance of communication. No city's experience is just like that of another city, no city anticipated every potential outcome, and we can all learn from each other. State Representative John Cyrier was in attendance and thanked the communities for their excellent work.
