**WHEREAS**, in 2022, 101 fallen heroes throughout the Nation have been killed in the line of duty including 23 from the State of Texas which is triple of the next closest state; and

**WHEREAS**, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Memorial in Washington, D.C., and the names of the heroic Texas Peace Officers are engraved on the Texas Peace Officer Memorial in Austin, Texas; and

**WHEREAS,** May 15<sup>th</sup> is designated as Peace Officer's Memorial Day, in honor of all fallen officers and their families and U.S. Flags should be flown at half-staff; and

**WHEREAS**, Congress has designated the calendar week that May 15<sup>th</sup> falls be known as National Police Week;



It aims to draw attention to the threats faced by migratory birds, their ecological importance, and the need for international cooperation to conserve them; and

WHEREAS, The theme for WMBD 2022 is to 'Focus on Light Polllution'. Artificial light is increasing globally by at least 2% per year and it is known to adversely affect many bird species. Light pollution is a significant threat to migratory birds, causing disorientation when they fly at night, leading to collisions with buildings, perturbing their internal clocks, or interfering with their ability to undertake long-distance migrations; and

**WHEREAS**, More and more cities in the world are taking measures to dim building lights during migration phases in spring and autumn. Best practice guidelines are also being developed under the Convention on Migratory Species to address this growing issue and ensure that action is taken globally to help birds migrate safely.
